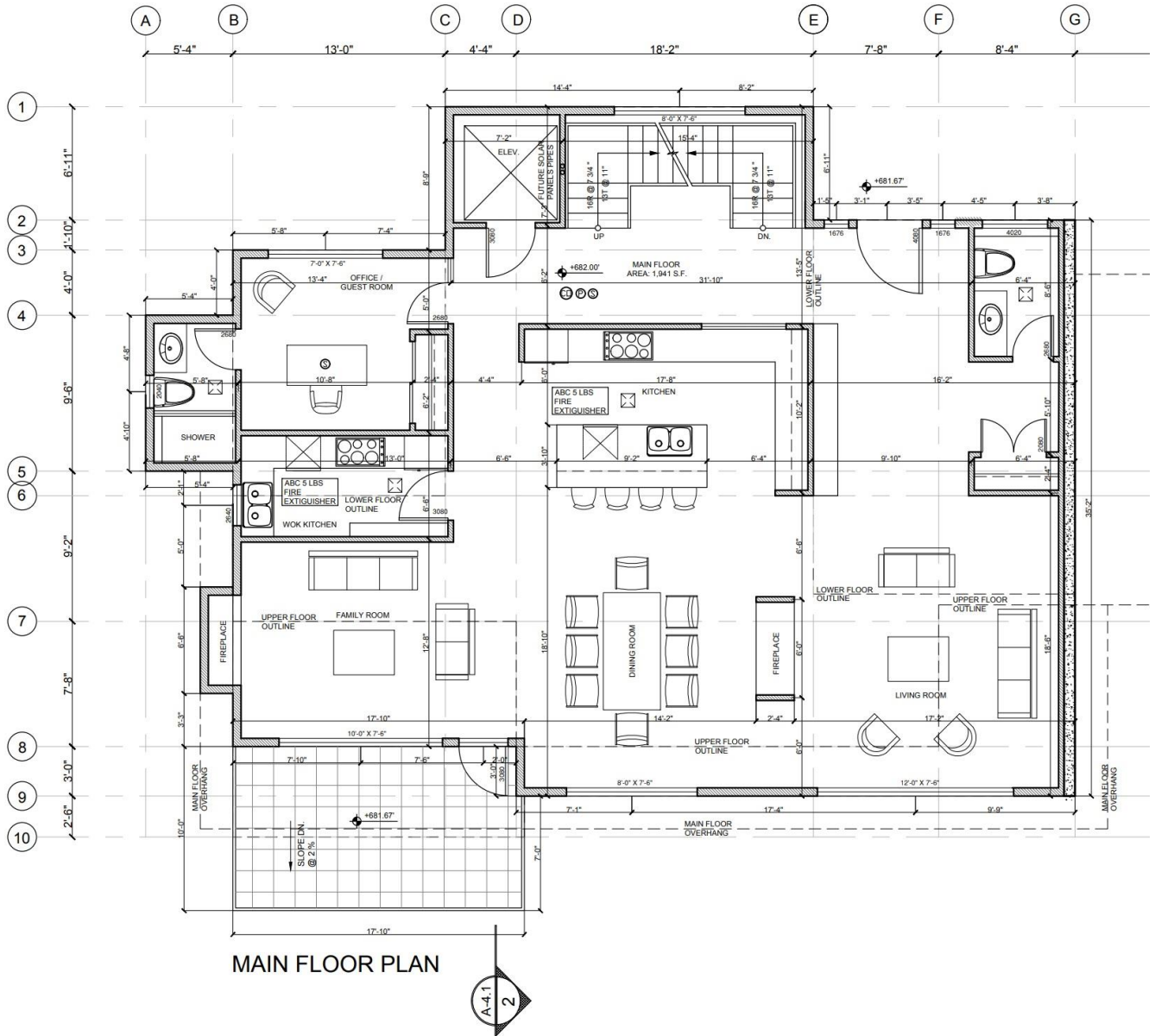

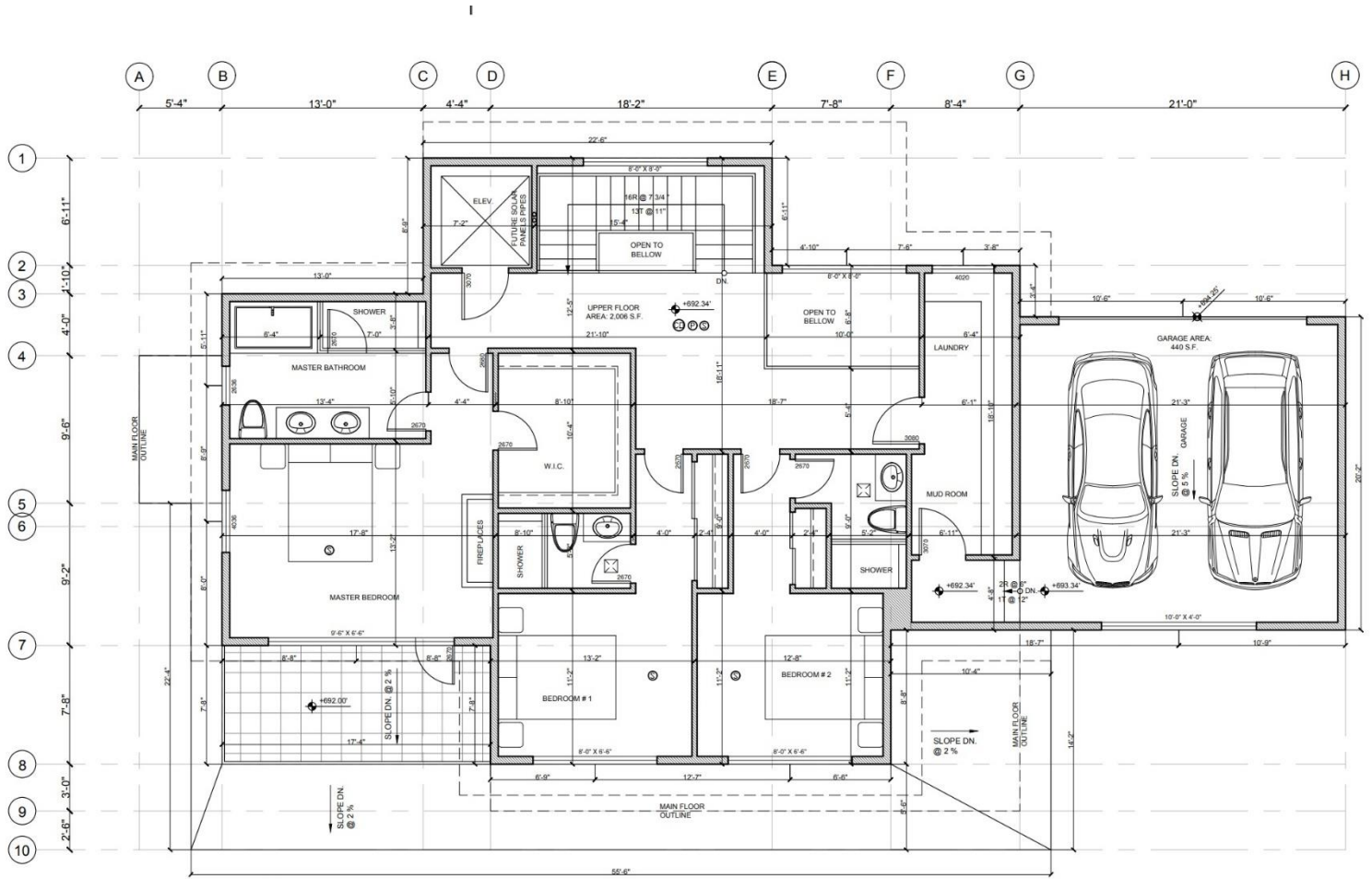


MAIN FLOOR PLAN

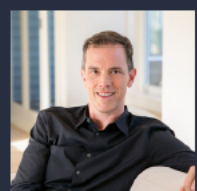

UPPER FLOOR PLAN



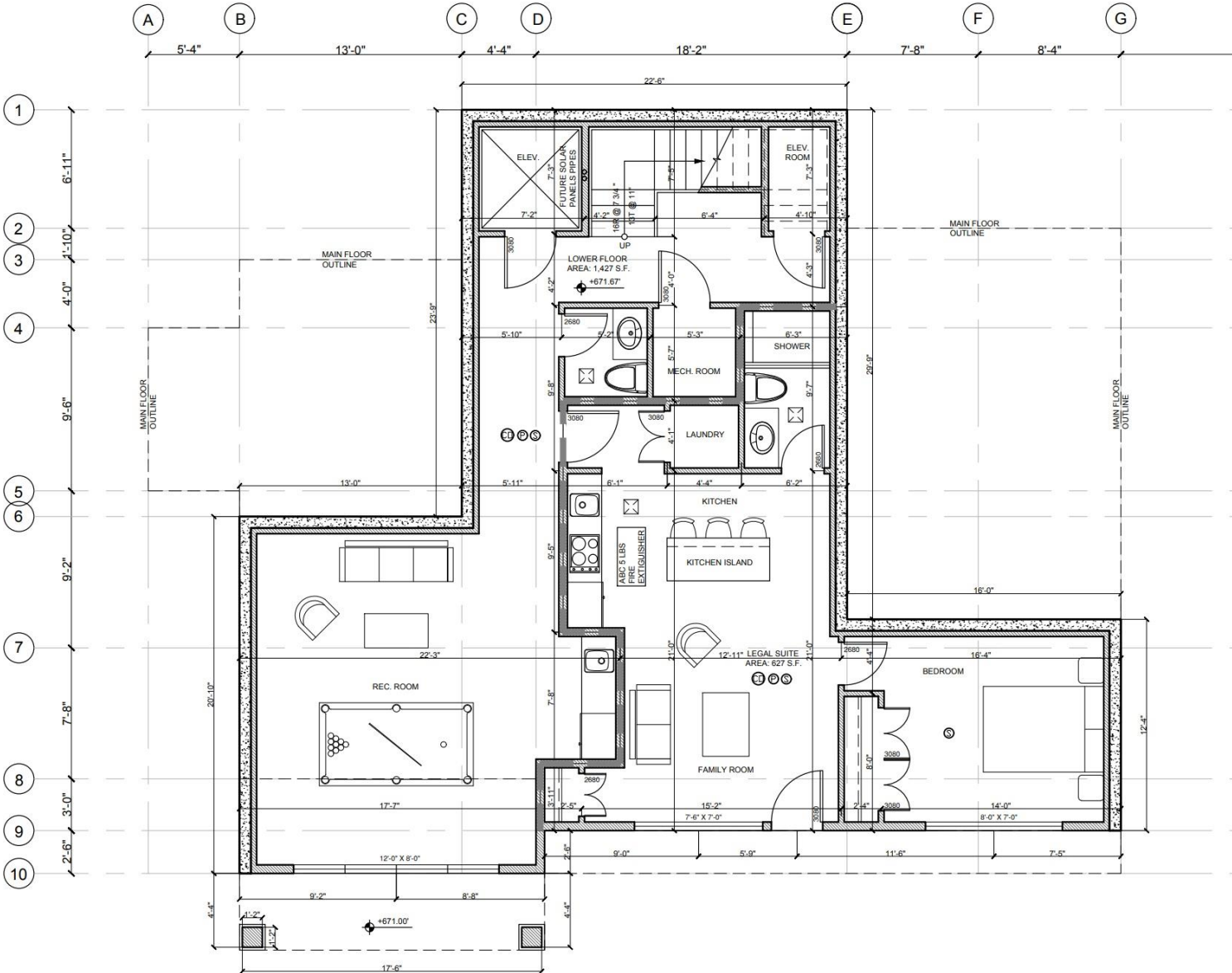
SLOPE DN @ 2%

LOWER FLOOR PLAN

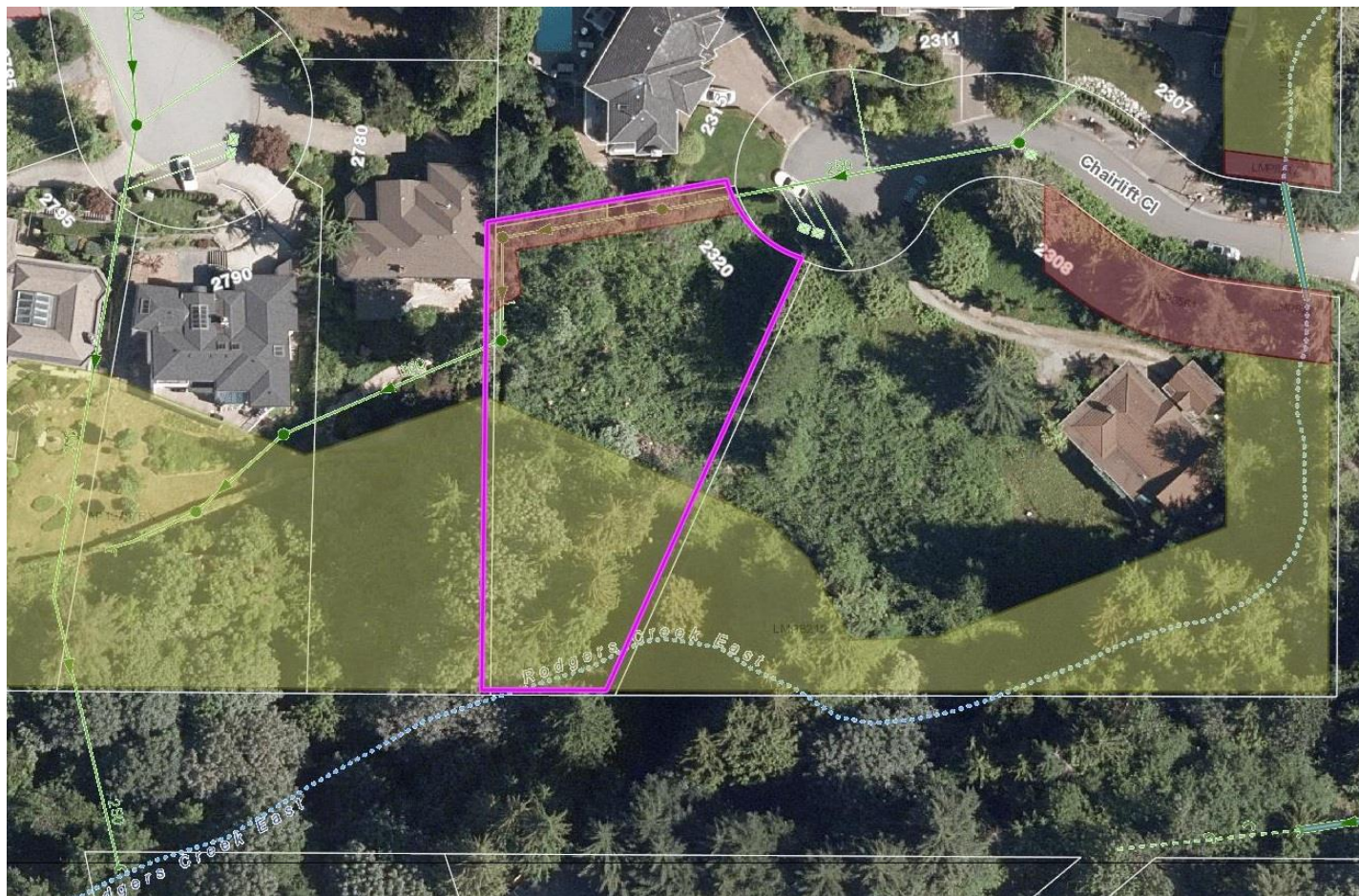
